TERMS OF TRADE RELATING TO CREDIT ACCOUNT OPERATION

In consideration of Rocket Rentals New Zealand Limited agreeing to provide rental equipment to the company/customer referred to in the application the company/customer undertakes as follows:

1. To abide fully by Rocket Rentals New Zealand Limited's standard terms and conditions from time to time including (but not by way of limitation) Rocket Rentals New Zealand Limited hire agreement terms and condition.
2. To promptly pay all charges incurred including penalty charges incurred in the account due to the company/customer failing or neglecting to perform their obligations under the agreement. All accounts must be paid no later than the 20th of the month following the date of invoice. Failure to pay by the due date may result in further equipment hires and or services being stopped until the overdue payments have been made. Rocket Rentals New Zealand Limited reserves the right to request from the company/customer such guarantee or security as it may think desirable to secure all sums due by the company/customer and may refuse to supply further hires or services to the company/customer until such security is given. In the event of late payment Rocket Rentals New Zealand Limited may charge interest on a daily basis to the company/customer at a rate equal to 5% per annum over the Rocket Rentals New Zealand Limited's bankers current overdraft rate from time to time, until the overdue accounts are paid, with interest accruing after as well as before any judgement which Rocket Rentals New Zealand Limited may obtain against the company/customer. The company/customer will also be liable to pay all Rocket Rentals New Zealand Limited's expenses and legal costs incurred in obtaining reimbursement arising out of any failure of the company/customer to any pay amount due to Rocket Rentals New Zealand Limited.
